8 RECEIVE THE CHAIRMANS ANNOUNCEMENTS

The Chairman provided an update on the Aston-By-Stone Memorial Garden. Due to the poor condition of the soil around the tree, amendments to the licence to plant will be required. **Clerk and Chairman to action**

9 DISCUSS GRASS CUTTING REQUIREMENTS IN MODDERSHALL AND OULTON

- **9.1** Maintenance of the area around the interpretation sign in Moddershall (adjacent to the village hall) was discussed.
- **9.2** It was AGREED that the Parish Council would pay for the cost of this maintenance and should be added to the village hall maintenance scheme of work.

10 DISCUSS THE OVERGROWN HEDGE ON MILL LANE, MODDERSHALL

- 10.1 Complaints have been received from residents with regards to the hedge on the perimeter of the land at the junction of Mill Lane and Moddershall Oaks. The hedge is encroaching onto the Mill Lane and the height of the hedge along Moddershall Oaks is inhibiting the openness of the view across the Moddershall Conservation Area.
- 10.2 It was AGREED to write to the owner of the land to ask for the hedge to be cut back.

11 MAINTENANCE OF BUS SHELTERS ON THE A34

The Parish Council is responsible for the maintenance of 6 bus shelters along the A34. It was AGREED that each shelter should be assessed for any maintenance needed and any repairs needed should be undertaken. It was noted that works would include

removal of trees/undergrowth to gain access to all areas of the bus shelters. Clerk to action

12 REVIEW OF VILLAGE HALL RISK ASSESSMENT

The Village Hall Risk Assessment was duly considered and reviewed. It was AGREED to adopt the risk assessment.
